Comm. McManus: In front of you, you have a list of 41 bills totaling \$59,417.96.

COMMITTEE REPORTS

Fire Department Equipment - Comm. Paul

Comm. Paul: The ladder for the Squad that was damaged or failed the ladder testing has been ordered.

Turn-Out Gear - Comm. Paul

Comm. Paul: I placed a big order for helmets, gloves...that's all in the closet. Chief Beeler put an email out about having our gear washed probably twice a year unless there is a fire.

Recruitment / Membership - Comm. Paul

Comm. Paul: There is an application in the office for Christian Grieco. Chief Beeler is going to be meeting with him tomorrow night at Battalion 1.

Capt. Dimitri: Justin Busch gave one out Saturday morning and said he'd be here this of the week to return it.

Fitness Center - Comm. Paul

Comm. Paul: I'm still looking to find somebody to install that stereo system we bought last year.

Comm. Ruth: Two years ago.

I've got a phone call into Craig, one of the toilets is running. He's going to take a look at that.

S.O.G.'s - Comm. Paul

No report.

Insurance - Comm. Weindel

Comm. Weindel: I have a couple things under Insurance. Right now, we have to renew our Accident and Sickness Policy on 06/18/18. There are two plans on here. I recommend the first plan because that's the one we've been using. It's going up roughly a \$1,000. The premium will be \$8,011. I recommend we do that plan, I don't know if we need a motion on that.

Sol.Tavani: That would be a motion, second and vote.

Comm. Ruth: Do that under New Business Frank.

Comm. Weindel: OK.

Comm. Weindel: Also, ISO requested some stuff from me. They wanted a hydrant map, I sent it to them. It was addressed to Mike Nolan, but I sent them the maps as they requested.

Comm. Weindel: Also on Insurance, we'll get back to the Explorer Program. I think we'll go into Closed Session.

Sol.Tavani: That will be handled in Closed Session. I did a rather extensive memorandum on that.

Comm. Weindel: Right, we have something to talk about on that, so that will be addressed in Closed Session.

Uniforms - Comm. Weindel

Comm. Weindel: I had some problem with invoices with Action Uniforms, it's all squared away. Right now I've got 3 more people to square away and we should be almost totally up to date. We had that guy come down and got what we needed, so we should be good to go. We should be receiving all the stuff we ordered soon.

Capt. Dimitri: I have a question on Uniforms. We have the policy for uniform hats, are you putting an order in? **Comm. Weindel:** Uniform hats, baseball hats...yes I am. We had problems with invoices, but I'll square that away. **Capt. Dimitri:** Like I need a second one, we should buy our own. If we put an order together, I'll buy another one. And the bucket hats for the summer too.

<u>Incentive Program - Comm. Weindel</u>

Comm. Weindel: Jason Frederick has been paid his 40% from last year.

Comm. McManus: When was he paid? **Comm. Ruth:** It's in the checks tonight.

Comm. Weindel: And under the Incentive, we have on this Policy Directive #1001, the Organizational Structure. On the back of it would be the stipend for the volunteers. The Chief would be \$15,000, the Dep. Chief will be \$7,500 plus clothing allowance, Captain will be \$1,000 plus clothing allowance, Lieutenants will be \$500 plus clothing allowance. Training Officer would be \$1,000 plus clothing allowance, secondary Training Officer will be \$500 plus clothing allowance. Do we need to make a motion on that?

Comm. Ruth: That will come under New Business also for a motion to accept that.

Comm. McManus: Under Training, there is no clothing allowance to go with that. Training is \$1,000.

Chief Beeler: Under Training it should just say \$1,000. Not plus clothing allowance. The head of Training gets \$1,000 and the assistant gets \$500.00.

Sol. Tavani: And these are stipends.

Comm. Ruth: They're already getting their clothing allowance under Lieutenant or Captain, getting it with that.

Fuel - Comm. Weindel

Train Display - Comm. Weindel

Comm. Weindel: Under the train...it's been towed here. I guess we've got to do some repairs on it. I don't know

how extensive the repairs are.

Chief Beeler: That's something we have to figure out what we're going to do with it.

Comm. McManus: Looking it over, I don't think it's that bad. **Chief Beeler:** It's missing that piece of skin on the back, it's dirty.

Comm. McManus: All that is, is the aluminum that you can buy for soffits over at Home Depot.

Chief Beeler: The only problem I have is, where do we want to put it?

Comm. McManus: There is only one place to put it now.

Chief Beeler: Yeah, and it sinks over there. Where else can we put it and leave it for a while, unless we move it

week by week. I know when Ray dug it out over there...

Comm. Weindel: At the time, Mike told me to leave it there. Just take a look around and see what we got. Get it

repaired first. Other than that, I don't have anything. We'll work on the train. That's all I got.

Communications – Comm. McManus

Comm. McManus: I just ordered some battery clips for the pagers, and I'm looking around to see where I can buy cheap chargers for Minitor V's. We have a couple that are broken, a couple didn't come back. PK's been getting pagers back so we have to dig up some chargers somewhere. I'm probably going to end up buying a few online.

Comm. McManus: The Training Division asked for a new laptop. That's in the works, it should be here tomorrow.

Apparatus - Comm. McManus

Comm. McManus: On the trucks, I started the pm's. The Ladder is done, they did that last Thursday and Friday. They'll be coming in and starting on the other three or four. And I'll just let everybody know what truck they're going to start on and when.

The Squrt...a lot of the issues were taken care of. They came down a couple weeks ago and fixed the generator. He's still trying to figure out why the lights came on and went off those couple times, other than being a computer glitch, that's all he could figure. Other than that, that's it.

Chief Beeler: What I was told is, Firehouse is going to a cloud based server, and everything is going to be just fine. As far as who runs Firehouse now, no one knows that. What Ray is saying is, Mike Hall is an independent contractor. He runs to Firehouse putting the fear of Christ in people that Firehouse is not going to work right unless you bring him in here to show you things.

Comm. Ruth: That's what that email was that I forwarded to you two guys.

Chief Beeler: And I got one prior to that. I'll double check again when I go back to work on Wednesday and start sniffing around some more, but as far as I know, they're switching to a cloud server and that's it. They're not going to have these backup redundant servers at the County. I don't know what kind of upgrades Timmy is looking at for Firehouse, I don't know what he needs done, but the computer guy at the County level is weird. If you ask him a question, he walks away from you. It's kind of hard to get a straight answer, but I'll try.

Information to Fire District Commissioners

I attended a managing fireworks display seminar today. We are switching to the International Fire Code 2015 in July. The booked should be available soon and we will need to purchase one. Firehouse software will also need to be upgraded at a cost of 1,200.00. I have been talking to Firehouse Software rep when things get closer I will advise. The new county fire marshal is certified for fire investigations he is responding to calls within the county to get experience, so don't be surprised if you see him on the fire ground. The fire inspectors are writing violations to business for the new Carbon Monoxide law that went into effect last September. All fire houses need to comply. The Fire Safety Registration invoices went out April 1, 2018. As of April 13, 2018 we received: NLH fees 6,469.75 late fees 150.00 and Permit fees 292.00. As of now when an insurance company request for a fire incident report or fire investigation report we only charge \$10.00 dollars. Most if not all Fire Depts in this area charge \$25.00 dollars for the report. Due to the cost of burning a disk for photos and the paperwork involved I think we should do the same. I spoke to the owner of Mueller's water ice and he is interested in doing Christmas in July. I spoke to the Chief and we will follow-up.
