Comm. Ruth: Comm. McManus and I were contacted and we can do it this way as long as we are using existing funds which we can take out of the capital account. We have a Resolution for a special meeting to seek voter approval for the purchase of a pickup truck under the state contract. In that resolution, it states that we are using pre-existing funds so we will still have to have a vote on the truck. The Resolution states the vote will take place on Monday, November 19, 2018 from 6:30pm to 7:30pm at 2201 Bangor Ave. Lindenwold. This is Resolution 2018-29.

WHEREAS, NJSA40A:14-84 requires that the Board obtain voter approval to amend its budget and to authorize this capital expenditure from its existing capital account;

WHEREAS, the Board approved the special election for the purchase of the pick-up truck at their regular meeting of October 15, 2018;

NOW, THEREFORE, BE IT RESOLVED that the Board of Fire Commissioners shall hold a special meeting to seek voter approval to amend its budget for the purchase of a pick-up truck under State contract, the cost of which is not to exceed \$50,000.00. The Board has changed Res.2018-27 date of special election from 11/10/18 to Monday 11/19/18 from 6:30pm to 7:30pm at the Board's office located at 2201 Bangor Ave., Lindenwold, NJ. At this time the voters will be asked to vote on the following question;

"Shall the budget of the Board of Fire Commissioners of Lindenwold Fire District No. 1 be amended and the Board authorized to make an expenditure from its existing capital account to purchase a pick-up truck pursuant to State contract, the cost not exceed \$50,000?"
