Comm. Weindel: I am not sure what we want to do with that. I priced the digital signs for outside of the firehouses and the prices are up there. I don't know what we want to do.

Comm. McManus: We can give it back to the Borough.

Comm. Weindel: Does anyone have any thoughts on what we can do with the train? I've been trying to get prices but they are pretty high. Digital signs are not cheap.

Chief Beeler: The train is cumbersome.

Train Display - Continued

Comm. Weindel: It is kind of beat. Is there any other solution? Can we do something else? Put something else

together?

Chief Beeler: I don't know, the train just sat in one spot. Unless we drag it to fire calls with us.

Comm. Weindel: I mean, what are the thoughts on this? Get rid of it? Scrap it?

Comm. Hans: Clean it up.

Comm. McManus: The trailer belongs to the Borough. That is the Public Works trailer. The only thing that we have is what is sitting on it. Right now it is a bunch of scrap metal.

Comm. Weindel: Thoughts on maybe getting rid of it and giving it back to the Borough?

Chief Beeler: I am fine with that. I don't think it serves us any purpose.

Comm. Weindel: I just want to try to get something out of it. I will check more prices on the digital signs. They are

not cheap.

Chief's Report - Chief Beeler

The report was read aloud by Chief Beeler, a copy is attached to the minutes.

Chief Beeler: About two or three weeks ago, Chief Cilona who is the President of the Fire Chief's Association sent me an email that the retired Chief from Hazlet Fire Department, is working on a project with fire departments outside of the United States that are significantly underfunded. They are asking for old turn out gear that we are no longer using or that we are going to get rid of. I spoke with Rich Paul about this. They are working with a company called CPR Restoration. CPR is working on this project with them and they want to know if we have any old turn out gear that we can get rid of? We do have old turn out gear that is sitting out there collecting dust. I am a very big proponent of getting rid of it. I don't know if you guys want to talk about it in closed session amongst yourselves but the gear that is out there if it is usable, someone outside of the United States could use. Apparently they are going to have a hold harmless agreement that can be signed to cover us from any liability.

Sol. Tavani: That would be the major concern that I would have. We could declare it no longer fit for use here in the United States, once we make that declaration.

Comm. McManus: Do they need air packs?

Chief Beeler: Captain Burns is working on that. By the end of the month we will know what is going on with them. I know Captain Dimitri wants us to keep a couple of them to use with those new blast masks for training purposes. Some of them are usable.

Captain Burns: We currently have enough spare air packs. One of the biggest things is that when we got that grant, we had to decide on a number that we were going to give to Nat Alexander's. That was part of the grant. I then brought up, maybe a couple months ago, in reference to sell them, if we were allowed to sell them because they were received on a grant. We were trying to determine a number of air packs to keep for training and how many to give back to Nat's and how many we could sell, if we were allowed to sell them.

Comm. McManus: That grant has been satisfied.

Chief Beeler: So if the grant is satisfied can we just sell them out right? I would like to keep ten here, send ten back to Nat's.

Comm. Ruth: Wouldn't it be best to send the ones that are damaged ones, so to speak back to Nat's. We can keep the ten good ones here?

Chief Beeler: Anthony is going to use them. When we use them we are going to have a bottle, the frame, and the blast masks. With the training item set up, you will not need the flow air. You do not really need ones that are functional, we just need ones that they can put on and hold the bottle to simulate the air pack.

Comm. McManus: They have all new straps and everything on them.

Comm. Weindel: PK under our fixed assets, that is included right now. We will need to know what is done with them because we pay insurance on them.

Chief Beeler: We are going to work on that. I want to try to clean up all of that stuff out there, the Squrt, the train, the air packs, and the boxes. That is all that I have.

Comm. Ruth: Deputy Chief Polifrone.

Dep. Chief Polifrone: There is a screw in one of the tires of Car 1.

Comm. McManus: Can you run it over to Tire Corral?

Dep. Chief Polifrone: Yes. It has been there since before you went on vacation, so I am not really too concerned about it but yes I can take it to Tire Corral, other than that, Happy Thanksgiving.

President's Report - Comm. Ruth

No Presidents are present.

Borough of Lindenwold - Councilman DiDominico

Councilman DiDominico is not present.

Solicitor - R. Tavani

Sol. Tavani: Good evening Mr. Chairman and Commissioners, we do have several matters along with several Resolutions tonight with the attempted truck vote which I understand was 17 yes votes. We have the truck resolution is that correct Kathy? Was there another resolution on the truck?

Cl. Crockett: We did that already.

Sol. Tavani: According to the agenda it says to introduce the 2019 Budget. We also have closed session on a couple of matters, and finally Resolution 2018-32 which is for the appointment of a professional regarding the architectural services and I believe there is going to be a discussion on that as well. That is all that I have Mr. Chairman.

Comm. Ruth: Resolution 2018-30, resolution to introduce the 2019 Budget. Do I have a motion?

Resolution 2018-31, resolution for closed session to discuss personnel issues and issues with the other departments. Do I have a motion?

Motion made by Comm. McManus, seconded by Comm. Paul. Roll call vote, all yes

Old Business - Comm. Ruth

Comm. Paul: I make a motion to hire Remington & Vernick as engineers.

Comm. Hans: Can we talk about that and table it to next month? There is something in there I have a question about as far as things that were not included in Remington, and the other ones did. I think it is something that we need to look back into.

Comm. Ruth: A question has opened up to the Board on the floor to the Commissioners.

Comm. Hans: One of the items as far as the cost.

Comm. Ruth: The cost was \$28,000.

Comm. Hans: There was something on the back page of it.

Comm. Ruth: Not to exceed the \$28,000 mark.

Comm. Hans: Where it says on the back page assessment analysis phase exclusions all items can be provided but are not included in the below price, which is the site land survey services development and building facades and renderings, plan development and floor plans off site permitting services, phase 1 environments assessments and geotechnical services is not included. I don't know if anyone else has seen all of that. Some of the other ones did include the design of the building possibly. The only thing on one of the others I saw that was not in there was looking at all of the other sites. That is something we need to find out on the other ones.

Comm. McManus: They said verbally they were.

Comm. Hans: The other one did too?

Comm. Weindel: Yes, there are a lot of exclusions on there.

Comm. Hans: That is why I would like to see what the other companies are including, all of the sites. I believe they are. I know we want to do something by the end of the year but my opinion is to table it until the December meeting so that we make sure we are doing the right thing.

Comm. McManus: We have been putting this off for 2 months now. That's why we are having the second meeting for this.

Comm. Hans: I understand that. PK came in last week and said digest it for the week. That is just my suggestion. I don't know how everyone else is feeling. I talked to Frank about this a little bit. I still want to go forward with something.

Comm. McManus: They verbally said last week they were going to do studies on all 3 fire houses and some properties in town.

Comm. Hans: As far as the design.

Comm. McManus: This isn't a design, this is a study.

Comm. Hans: I understand that, but the other ones that were included as far as the design, and one of the other ones that I had looked at....

Comm. Paul: We can't go through with the design until we have all of this other stuff resolved.

Comm. Hans: I understand that. This one is no design and one of the other ones....

Old Business - Continued

Comm. Ruth: Yes, but the other ones aren't doing all of the other studies which is the best location.

Comm. Hans: That is what I want to find out, if they are including it. I want to make sure they look at all three

firehouses. If they say no...

Chief Beeler: None of the other ones offered to do that.

Comm. Hans: I understand that but I think giving them a chance to say okay, we are going to do that it's going to

save us \$10,000.

Comm. Ruth: We have a motion on the floor.

Comm. McManus: The only problem is, if you wait until the December meeting to approve this, they are not going

to start working until January.

Comm. Ruth: You can't take any money out of this years' budget.

Comm. Hans: You would still have to take some money out of the budget before then.

Comm. McManus: We have \$10,000 put away this year. If we approve tonight they would start in December or if they bill us for December we can take out the \$10,000 out of this years' budget to pay them.

Comm. Hans: If we decide to do it this way, they will still take \$10,000 from December's meeting.

Comm. Ruth: No, because you will not get a bill and they won't start working until January. That meeting is at the very end of December.

Comm. Weindel: I say we move forward with it.

Comm: Ruth: I have a motion on the floor. **Comm.** Hans: What was the motion for?

Sol. Tavani: Resolution 2018-32.

Motion made by, Comm. Paul seconded by Comm. Weindel to appoint Remington & Vernick as Architectural Engineers for Resolution 2018-32.

FISCAL YEAR: January 1, 2019 to December 31, 2019

WHEREAS, the Annual Budget for the Borough of Lindenwold Fire District No. 1 (the "Fire District") for the fiscal year beginning January 1, 2019 and ending December 31, 2019 has been presented before the Board of Commissioners of the Fire District at its open public meeting of November 19, 2018; and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$1,242,092, which includes an amount to be raised by taxation of \$1,164,457, and Total Appropriations of \$1,242,092; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on November 19, 2018 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2019 and ending December 31, 2019 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Fire District will consider the Annual Budget for adoption on December 27, 2018.
