Freddy replaced the hoses and changed the oil. The Squad, the steering box went, just like the old Squrt did. The steering box was taken out the Thursday before last and was sent to Baltimore, rebuilt and reinstalled Friday morning. I was telling PK before the meeting, there is some issues with the Ladder, nothing really serious just a bunch of little issues that can't be fixed in the station. It's going to go to Lakehurst for about a week. I told him I'm going to take it up on a Monday and I want it back on Friday, I don't want it sitting there over the weekend. If it's going to be a couple weeks before he can get it up there to get the hose fixed, they are going to fix it in the hall.

At some point the Duty Crews have also had other departments coming over and training with them. They are using the roof simulator when it is nice out. The other thing that has been happening is volunteers have been showing up and running with them, which isn't a bad thing because we are paying 4 people for the crew and 6 more people showing up and running another truck.

Chief Beeler: If they run with the duty crew they will get credit for being another duty crew, another volunteer duty crew. It would be like they ran a night time duty crew or weekend duty crew. If they run for 3 hours they get credit for the 3 hours. They have to be present for the whole thing. In regards to the ESafety training it is mandatory and if it is not completed by April 1<sup>st</sup>, their gear is sing to be pulled. I made sure Laurel Springs and Clementon knows about it and their guys are on it. They have new people I've given Leah permission in the computer to assign her new people into ESafety as they come on board.

I found a gas grill on the 1<sup>st</sup> floor, the place was gutted, no permits. The owners are from Brooklyn, New York. I sent a penalty out. I told them to remove the gas grill; they were actually cooking inside when I went in. When I went to the 2<sup>nd</sup> floor, there was a bunch of cots up there. When I was in there I heard the smoke alarms beeping. I asked them where they were at. They were hanging down, they were electric back up, and the batteries were bad. I asked them where the CO detector was. The guy turned around and told me it was in the dumpster when they gutted it out. I told them they could not live in there like that. They took the propane grill and put it on the deck. I cld them they had to move it to the yard. It was owned by Build Your Life LLC, out of Brooklyn New York. When I was in there it was pretty bad. If there are any calls, it's like a match stick waiting to go up, especially with them cooking in there. The pictures I took, it looked like a crab pot, probably a 4 gallon pot sitting there boiling with another pot next to it with rags sitting next to that pot. Just wanted to let everyone know what is going on.
