RESOLUTION OF THE BOROUGH OF LINDENWOLD FIRE DISTRICT NUMBER 1, AUTHORIZING THE APPOINTMENT OF CHAPMAN ENVIRONMENTAL SERVICES TO PERFORM A PHASE 2 ESA/SITE INVESTIGATION.

WHEREAS, Lindenwold Fire District Number 1 has determined that it is in the best interests of the Fire District, to investigate the feasibility of constructing a new Fire Station; and

WHEREAS, Lindenwold Fire District Number 1 previously utilized the professional engineering services of Chapman Environmental Services to perform a Phase I Environmental Site assessment Study (ESA) at the real property located at 517 E. Linden Ave., Lindenwold New Jersey, in December 2019, in furtherance of the Fire District's preliminary investigation of a potential site for the proposed Fire Station; and

WHEREAS, the Phase I ESA recommended a Phase 2 ESA Site Investigation be performed at 517 E. Linden Ave.; and

WHERAS, Lindenwold Fire District Number 1 has obtained a quote for professional engineering services from Chapman Environmental Services to perform the Phase 2 ESA Site Investigation, and

WHEREAS, N.J.S.A. 40A:11-5 permits professional services contract to be awarded without the public advertising for public bids; and

WHEREAS, Lindenwold Fire District Number 1 believes it is in the best interests of the Fire District to utilize the professional engineering services of Chapman Environmental Services, in that Chapman is familiar with the property and project, having previously performed the Phase I Site Investigation at 517 E. Linden Ave.

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of Lindenwold Fire District Number 1, that the District is authorized to execute a professional services agreement with Chapman Environmental Services for the purposes of performing a Phase 2 ESA Site Investigation at the real Property located at 517 E. Linden Ave., Lindenwold, New Jersey.
