NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of Lindenwold Fire District Number 1, that the District is authorized to execute a professional services agreement with Lawrence Luongo, Esquire, for the purposes of handling all legal matters associated with the acquisition of the real property intended for the construction of a Fire Station.
