Comm. Ruth: Everything is in service. Squrt 63 & Engine 63 had the cab purifying system installed. Pm's were done on all of the apparatus by Firefighter One. Suggestions from the reports have been started on the apparatus' where needed. Both Fire police vehicles have issues with the air conditioning & that's being taken care of. I received an email from Laporte in regards to their ispections. In Pennsylvania, they're required to have a commercial inspection. I was advised one of the brake shoes was cracked along with one of the drums. They are lucky the truck even stopped. It would not have passed inspection. The bill came to approximately \$1,600 for the brakes. I offered to give them \$1,000 to help cover. I'm looking into our apparatus having a federal commercial truck inspection done. Chief Engineer Ray McManus said the Squad & Engines brakes are both okay. I also received the Ladder report that is being sent out tomorrow to LaPorte. Also, when we are doing truck checks, please make sure we aren't double paying for things to get fixed. I got an email saying the truck was leaking, when they came down to look at it, it wasn't. The tank was full and there were no leaks.

RESOLUTION 2021 – 20

RESOLUTION OF THE BOROUGH OF LINDENWOLD FIRE DISTRICT NUMBER 1, AUTHORIZING THE APPOINTMENT OF GARRISON ARCHITECTS FOR THE PURPOSES OF DESIGNING AND PROVIDING ARCHITECTUAL SERVICES FOR A PROPOSED NEW CONSTRUCTION FIRE STATION.

WHEREAS, Lindenwold Fire District Number 1 has determined that it is in the best interests of the Fire District, to construct a new Fire Station within the Fire District (hereafter Construction Project); and

WHEREAS, Lindenwold Fire District Number 1 believes it is in the best interests of the Fire District to hire and employ an architect for the Construction Project with experience in designing other similar projects; and

WHEREAS, Garrison Architects has experience in designing projects similar to the proposed Construction Project; and

WHEREAS, Garrison Architects, has demonstrated to the satisfaction of the Board of Fire Commissioners of Lindenwold Fire District Number One that Garrison Architects will be able to provide professional Architectural support in all aspects of the design and construction of the proposed Construction Project; and

WHEREAS, N.J.S.A. 40A:11-5 permits a professional services contract to be awarded without public advertising for public bids; and

WHEREAS, Lindenwold Fire District Number 1 believes it is in the best interests of the Fire District to appoint an Architect without public advertising for public bids for the Construction Project to ensure the Fire District appoints an architect that has the requisite experience, training, and skill to provide professional support for a specialty project such as the proposed Construction Project.

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of Lindenwold Fire District Number 1, that the Fire District authorizes the appointment and hiring of Garrison Architects for the purposes of providing Professional Architectural Services for the proposed Construction Project. The Fire District is further authorized to execute a professional services agreement with Garrison Architects.
