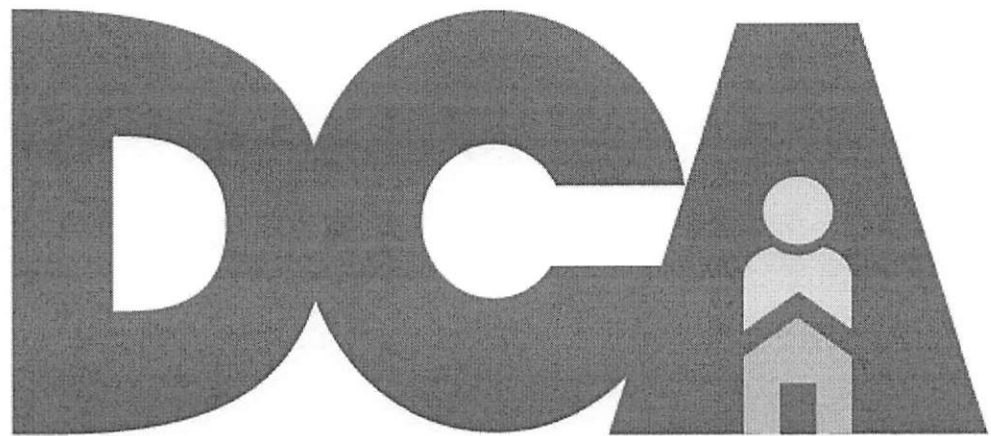

The proposed 2021 budget is increasing by approximately \$41,200. The major increase is capital appropriations.

3. Explain any variances over +/-10% for each line item. Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

The board projects a \$1,000 increase in election expenses due to the mail in ballot requirements. The board projects a \$6,000 increase in professional fees due to the use of an architect in 2021. The board projects a \$1,000 increase in advertising based on current year expenditures. The board projects a \$1,200 increase in payroll service fees based on current year expenditures. The board projects a \$30,230 decrease in operations and maintenance salary and wages and a \$3,268 decrease in operations and maintenance fringe benefits due to a decrease in duty crew firefighters. The board projects a \$2,000 decrease in promotional items based on current year expenditures. The board projects a \$5,000 increase in turnout gear due to additional volunteers. The board projects a \$5,000 increase in communications equipment based on normal aging. The board projects a \$2,500 decrease in SCBA equipment based on future year need. The board projects a \$1,200 decrease in vehicle improvements based on future year need. The board projects a \$2,000 decrease in fire prevention materials based on future year need. The board is increasing the capital appropriations by \$48,000 due to an increase in need for the 2021 budget year.

If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

The proposed budget increases the Amount to be Raised by Taxation by approximately \$2,700, a 0.2% increase. The tax rate will remain the same at 19.6 cents per \$100. The Board is utilizing \$40,500 of unrestricted fund balance in the 2021 budget. The proposed 2021 budget is compliant with the Levy Cap requirements. The Board did not need to utilize any of its Levy Cap Bank to comply with the Levy Cap requirements.


