Comm. F. DeLucca: I totally think you are wrong and whatever I got to do. I guess I'll start with Parker McCay to find out how they can do that. Who is Mr. Kevin Sheehan?

Sol. Catalano: Yes. Kevin Sheehan is the shareholder at the law firm who specialized in Land Use applications. He is representing the Fire District as far of the application before the planning board.

Comm. Paul: Happy Holidays, Happy New Year.

Comm. Hans: Merry Christmas everyone, stay safe.

Comm. T. DeLucca: Chief, when you guys do Santa; do you want to have Brandon communicate with me like we've done in the past & I'll look on social media. Would he be my point of contact?

Chief Beeler: Yes, that would be fine.

Comm. T. DeLucca: Okay, we will work collaboratively with that. I wish everyone a Merry Christmas & Happy New Year.

Comm. F. DeLucca: Okay, I'd like to make a motion to make a request for proposal for a construction manager. I know we spoke about it and I believe it is very necessary I talked to numerous towns, Washington Township, Winslow. I think that is something that protect the taxpayer's interests. Need to remind we are stewards of the taxpayer's money. A nonpartisan person to oversee the project and I believe it is very, very beneficial.

Comm. Paul: We have to go back into new business to make that motion. We can do that once we close to the commissioners.

Comm. F. DeLucca: I am still not finished. You are dancing around me here. I guess was there an agreement with the Borough of Lindenwold either verbal or written regarding the fire district doing EMS services? Guess that is my question to whoever.

Comm. Paul: There is no agreement with the District and the Borough for EMS.

Comm. F. DeLucca: Okay, then how many dollars are we spending on in the new building for EMS?

Comm. Paul: We aren't spending anything. They have offices. We agreed to house them in the new building and that is why the Borough gave us the ground. Once the building gets done, they would be housed there so it would free up their building on Walnut Avenue.

Comm. F. DeLucca: You just said that there was no agreement and now you are saying that there is an agreement. Which way was it Rich?

Comm. T. DeLucca: Where is the copy of the agreement?

Comm. Paul: The Borough should have it.

Comm. F. DeLucca: I have a copy of it, and it doesn't state anything either verbally or written whether the Fire District & what you just stated whether they would give us the ground & the building, if we took over the EMS or housed the EMS so the Borough could sell that building. Where is that written?

Comm. Paul: I don't think the Borough is selling that building Frank.

Comm. F. DeLucca: What did you just say Rich? Am I hearing funny?

Comm. Paul: That would be up to the Borough to sell the building.

Comm. F. DeLucca: Well what did you just say? What did you say a few minutes ago Rich?

Comm. Paul: That we were going to house EMS in our building and when it was time to make an agreement we would.

Comm. F. DeLucca: What is it costing us now?

Comm. Paul: Nothing. We don't write any checks to the Borough for EMS.

Comm. F. DeLucca: But yet you have it included in the proposal. I am not going to debate any more over this Rich. You've said it and now you are denying it.

Comm. Paul: I am not denying anything Frank.

Comm. F. Delucca: Well, somebody did. Okay. Again moving on. I have to go back to the issue with the Solicitor I feel it's a conflict. I will investigate that and also I strongly context the bill from the architect which is one line for like \$75,000 and I did question you earlier and you said that for the work and but yet he hasn't don't the work. I don't know why we pay bills in advance when the work hasn't been done especially \$75,000. Back to the newspaper advertisement, if the Board has not seen the blueprints and agreed to the final concepts of the new building, how can you put it out to bid for the contractors? Do you go out and buy a new car and say yeah I'd like to buy a new car you write specs on it and it is approved by whoever is spending the money and need I remind everyone it is the board why is spending the money.

Comm. T. DeLucca: In regards to the agreement, Chief Beeler and I were talking about that, because he was looking into getting a copy as well so I reached out to Mr. Capozzi, and he said that he checked with Craig and indicated that he forwarded a copy of the EMS agreement to Rich Paul about 2 weeks ago this was on November 14th.

Comm. Paul: That agreement was contract that was signed by Mayor and Council to provide EMS services for the Borough of Lindenwold. It had nothing to do with the Commission. It was a contract between Jefferson Hospital and the Borough, I believe you were Mayor at the time.

Comm. T. DeLucca: Shouldn't we have something in writing? Something in an agreement?

Comm. Paul: We aren't taking over EMS.

Comm. T. DeLucca: I understand that. I understand that EMS is under Jefferson. What I am asking is, why we are housing them? Shouldn't there be some type of an agreement that we will be housing them in our building? Not taking them over.

Comm. Paul: We can have a Commissioner, the Chief, Deputy Chief go meet with EMS. They have the room if they want to come with us.

Comm. T. DeLucca: If they want to? But they are coming with us. Correct?

Comm. Paul: Yeah, eventually.

Comm. T. DeLucca: Shouldn't we have something in writing stating that before we allot them the space? 5

Comm. Paul: We have to go meet with them in order to discuss it.

Comm. T. DeLucca: When are you going to discuss it? When the building is built?

Comm. Hans: I don't think anything is set in stone. If they don't come, we will just have an extra bay?

Comm. T. DeLucca: So, we are just going to have extra bays? Okay.

Comm. Hans: Maybe put fire prevention there. I don't know.

Comm. T. DeLucca: Put fire prevention in the bay? Sure makes sense.

Comm. Hans: One of the trucks.

Comm. Paul: Anything else Commissioner DeLucca?

Comm. F. DeLucca: I guess this is for the building committee, Wayne have you ever measured the gym?

Comm. Hans: Yes, I have when we first took it over for the insurance. I measured it

Comm. F. DeLucca: Does our existing apparatus fit?

Comm. Hans: That I don't know Frank. I didn't measure it for apparatus.

Comm. F. DeLucca: Do you think we should probably take a look? Shouldn't that be investigated?

Comm. Hans: I know it was talked about with the architect. The architect felt we should tear everything down all at one shot.

Comm. F. DeLucca No what the architect is saying is that he makes more money if we do it that way. Is that correct?

Comm. Hans: That I can't answer.

Comm. F. DeLucca Wayne, is the architect going to make more money if we tear it down?

Comm. Hans: He is going to make a percentage. Yes, no doubt about it.

Comm. F. DeLucca Something don't smell good. Okay. Lastly, I will tell you all, the state of New Jersey has an Office of Comptrollers that we should take a look at and do some research. I have spoken to them, after the holidays I think they are very anxious to take a look at what is happening here at the Lindenwold Board of Fire Commissioners, I'm done. Merry Christmas.

2025 FIRE DISTRICT BUDGET RESOLUTION

Lindenwold Borough FD No. 1

FISCAL YEAR: January 1, 2025 to December 31, 2025

WHEREAS, the Annual Budget for Lindenwold Borough FD No. 1 (the 'Fire District') for the fiscal year beginning January 1, 2025 and ending December 31, 2025 has been presented before the Board of Commissioners of the Fire District at its open public meeting of December 16, 2024; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$2,341,093.00 which includes an amount to be raised by taxation of \$1,286,418.00 and Total Appropriations of \$2,341,093.00; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 16, 2024 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2025 and ending December 31, 2025 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Fire District will consider the Annual Budget for adoption on January 20, 2025.
